# Lake Clear trailers only a potential problem

Dear Editor:

for or how their waste is disposed of.

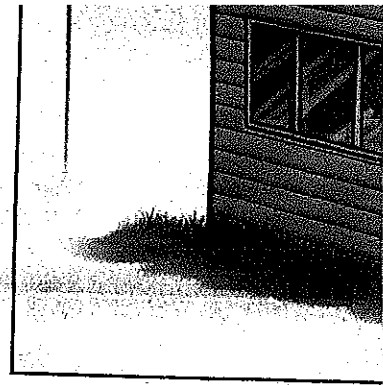

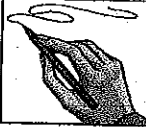

# Sneaky move by Lake Clear association

**Re: Trailers on Lake Clear**

Having read the May 17 edition of the *Leader* where Mr. Taker has put an issue forward to the members of Bonnechere Valley council saying the increase of trailers has sparked the concern from the Lake Clear Property Owners' Association (LCPOA) I was surprised as I have not heard of any discussion that included the members of the LCPOA to see what they thought or even put it on the agenda so every member had a chance to speak and hear all the facts before it went to council.

I think this move was both sneaky and underhanded by certain people who think their ideas are the only ones that matter and to hell what the rest of the members think to get this issue pushed through council.

Why were the LCPOA members with trailers not contacted? Why was it not brought up at the general meeting, and why most of all, did it go to council without the membership being informed?

To me when I read the *Leader* it was as though Mr. Taker implied that he

had the membership behind him on this issue and that was how it was presented to council.

I have trailers on my property. I have no right-of-way and due to the official plan I personally have no other option but to have a trailer as I can not get any permits from the township.

I own 27 acres that I pay taxes on and most are waterfront. I have three trailers (family, not rentals) that are camped in. Each trailer has its own outhouse and leaching pit. One trailer is used for 7 to 10 days; one for a week and a few weekends; one I try to spend two to three months of the summer at. How is the lake impacted?

Had the question been asked I could explain the usage of my trailers which were inspected, and passed by the township for waste water as well as sewage. I have one usable trailer for every nine acres of land that I own.

June 7th I boated around the lake and found 29 trailers. Some were in backyards. Where are these "about 50 trailers" on waterfront properties that "might be" impacting the lake?

I am so disappointed right now with how this issue was handled that I am

debating my membership with the LCPOA. I think the rest of the members should also take note on how this issue was put forth to council without input from the general membership. I am pleased that council is taking time to look into all facts that pertain to this as well.

My family have always enjoyed the lake. If you don't like the looks of a trailer on the lake, don't take it out on the people who can't afford or aren't allowed to build a cottage to enjoy the lake. After all, what is true camping and cottaging about? I hope the day never comes when someone tries to push "we don't want motors on boats, no docks", or "remove all boathouses from the lake because we don't like them."

Restrictions on how long we can have something on our property! Are you kidding?

*'Enough is enough'* seems to be the catch phrase these days.

I was a happy camper until this BS started.

# Lake Clear group is misguided on trailers

Dear Editor:

Once again the Lake Clear Property Owners Association (LCPOA) is trying to force the opinions of a few on the property owners of Lake Clear. They are now lobbying Bonnechere Valley council to pass a by-law to limit and apply restrictions on the usage of travel/camper trailers on Lake Clear properties.

Under the guise of concern for the lake's capacity for septic disposal and set back, they have targeted a set of property owners and seemingly choose to ignore the fact that the Ministry of Natural Resources and Forestry, Ministry of Environment, and BV Township already have existing policies in place to control capacity of the lake -- the most predominant being the inability to further subdivide lots, thereby limiting future growth.

This proposal is the initiative of select individuals who wish to restrict what their neighbours can do, provided they themselves remain unaffected. Camper trailers have holding tanks and the means to empty them, and there are existing rules applicable to the installation of septic systems. The LCPOA is proposing enacting permits and health unit verification for trailer waste disposal, yet ignoring the potential use of composting toilets, as well as the age, condition and capacity of septic and holding tanks for existing cottages and homes. The group also ignores the fact the MNR-sanctioned campsites on islands have simple privies (a hole in the ground), and pontoon boats can have porta-potties. If the group is so concerned for the health of the lake, why not request regulations and proof for each of these as well?

They claim harm will come from a few trailers that are being used for a

few weeks or weekends a summer, yet ignore the number of seasonal buildings that have converted to permanent homes and the community of fish shacks that occupy the lake for most of the winter. Will they single out and target one of these next for regulation? They suggest restricting multiple trailers on a lot, but do not even consider the size of the lot or lakeshore frontage on which they are situated.

Will they equally oppose existing bunkhouses and sleep lofts over boat houses and garages in the future? Is there a difference between the septic load created by guests sleeping in a camper trailer over those staying in a sleep cabin or loft?

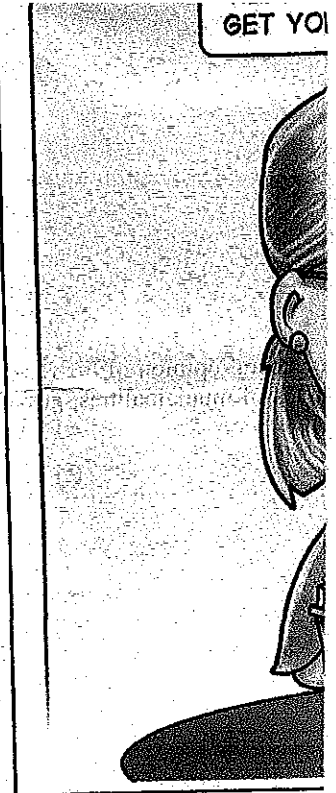
Once an informative group that reported on and promoted the beauty of Lake Clear, the LCPOA has now fully transformed into an authoritarian organization trying to dictate acceptable-use policies for land owners.

I would suggest to the LCPOA being this aggressive will hurt membership. I once belonged to this organization, but am personally tired of them trying to control what others -- including myself -- can do with the property that we bought and pay taxes on.

I would urge anyone who has an interest in Lake Clear to be sure to attend the council meeting which is unfortunately and inconveniently scheduled on September 19th, (Tuesday) a weekday afternoon after most seasonal residents have gone home.

To the members of LCPOA not affected by this current proposal, I suggest you seriously consider whether you want to continue funding an organization that may one day choose you as its next target!
