## THE CORPORATION OF THE TOWNSHIP OF BONNECHERE VALLEY

## **BY-LAW 2008-65**

## BEING A BY-LAW TO PROVIDE FOR RETAIL BUSINESS ESTABLISHMENTS TO BE OPEN ON CERTAIN HOLIDAYS IN THE TOWNSHIP OF BONNECHERE VALLEY

**WHEREAS,** Section 4 of the Retail Business Holidays Act, R.S.O. 1990, Chapter R.30, as amended, (the "Act") provides that the Council of a Municipality may by By-law permit retail business establishments in the Municipality to be open on holidays for the maintenance or development of tourism;

**AND WHEREAS**, retail business establishments in the Township of Bonnechere Valley have requested that the Council of the Township of Bonnechere Valley pass a By-law permitting them to remain open on certain holidays in the Township of Bonnechere Valley;

**AND WHEREAS,** the tourism criteria established by the Retail Business Holiday Act, Ontario Regulations has been met;

**AND WHEREAS**, it is deemed essential for the maintenance and development of tourism in the Township of Bonnechere Valley to permit retail businesses to open on certain holidays;

**AND WHEREAS,** the Council of the Township of Bonnechere Valley has designated the Township of Bonnechere Valley a tourism area necessary for the maintenance or development of tourism of its natural, outdoor, recreational, historical, cultural, multicultural and educational attractions;

**AND WHEREAS**, a Public Meeting in respect to the passing of the By-law was held on the  $2^{nd}$  day of July, 2008 with 30 days notice to the public;

**AND WHEREAS**, the Council for the Township of Bonnechere Valley has taken into account the principle that holidays should be maintained as common pause days;

**NOW THEREFORE,** the Municipal Council of the Corporation of the Township of Bonnechere Valley enacts as follows:

## **1. THAT** in this By-law:

- (a) "Retail Business" means the selling or offering for sale of goods or services by retail.
- (b) "Retail Business Establishment" means the premises where retail business is carried on.

**2. THAT** Retail Business Establishments in the Township of Bonnechere Valley are hereby granted an exemption to the Retail Business Holidays Act and may remain open on New Year's Day, Good Friday, Victoria Day, Canada Day, Labour Day, Thanksgiving Day, Christmas Day, Easter Sunday and Family Day.

**3. THAT** this By-law shall come into full force and effect on the 2<sup>nd</sup> day of August, 2008, being the 31st day after the date upon which it is finally passed.
