- (6) 2018 Water & Sewer Budget Committee discussed the 2018 Water & Sewer Budget. Committee recommends that the Eganville Generation Corporation pay the Shareholder a contribution of \$65,000 in 2018 towards the water and sewer budget;
- (7) 2018 Water & Sewer Rates Committee recommends a 2% increase from the 2017 rates to establish the rates for 2018;
- (8) Policy for Work on Private Property Committee discussed the policy for work on private property that was established in 2012. Bill Kennedy will prepare an amendment to this policy which will now include culvert steaming;

- (10) Referendum Public Meeting Committee discussed the February 6, 2018 public meeting, in reference to the referendum question that is going to be on the ballot. The topic of discussion will be the question of whether to elect municipal councillors by ward or at large.
