REPORTS

Water & Sewer

Daryl Verch, Water & Sewer Manager, was present and gave his report. Water & Sewer Report Received.

Works

Bill Kennedy, Works Superintendent, was present and gave his report.

- a) O'Connor Road Committee discussed not allowing truck traffic on O'Connor Road between Dwyer's and O'Connor's Pits to Gorman Road. This would only allow truck traffic on O'Connor Road from Ruby Road to Dwyer and O'Connor pits entrances. Committee asked Bill Kennedy to speak to the trucking companies involved and bring the issue back to Committee;
- b) Road Side Mowing The Algonquin's of Pikwakanagan would like Bonnechere Valley to do their roadside mowing. Committee recommends that we do their roadside mowing if the Roads Department has the staff;
- c) Radar Speed Sign Bill Kennedy briefed the Committee on the speed reports from the radar speed sign. The reports have been forwarded to the Ontario Provincial Police. Committee recommends that the sign be placed in rural areas as well as community areas;
- d) Sweepers Committee recommends that the two Mechanical Sweepers be deemed surplus and sold; and

e) Sign for McRae Park – Committee recommends that no jumping and no diving signs be erected at McRae Park.

Works Report Received.

Recreation

Kevin McGrath, Recreation, was present and gave his report.

- a) Arena Canteen Kevin McGrath presented the revamped prices for the canteen for the fall season to Committee;
- b) Lending Hub There was a staffing change to the summer student at the Lending Hub. The paddle boards are the most popular item to borrow from the Lending Hub. The four bicycles are not very popular. Committee recommends moving the bicycles to the Tourist Booth;
- c) Legion Field Committee recommends that signs be placed at Legion Field reminding residents to clean up after their dogs;
- d) Tourist Booth There was an incident in one of the washrooms at the Tourist Booth. Committee recommends staff look into surveillance cameras;
- e) Ice Kevin McGrath will have the ice up and running by Saturday September 22, 2018;
- f) Splash Pad There was a further delay in the pouring of the concrete due to the rain in the weather forecast; and
- g) Division of Recreation and Community Development Duties Kevin McGrath and Dana Jennings explained the division of duties to Committee.

Planning-Zoning & Community Development

Dana Jennings, Planning-Zoning & Community Development, was present and gave her report.

- a) Planning Dana Jennings updated the Committee on planning matters;
- b) Community Improvement Plan Dana Jennings is currently working on the application for the façade improvements. Committee has set aside \$10,000 of the \$40,000 from the Main Street Revitalization Fund for this façade improvements; and
- c) Electric Car Charging Station Committee discussed electric charging stations.

Dave Murphy, Fire Chief was present and gave his report.

- a) Camp Fires The Provincial Fire Restricted Ban banning camp fires was lifted on Friday August 10th. Dave Murphy lifted Bonnechere Valley's camp fire ban that day too. There was some confusion over the week-end, resulting in some fire calls to the Village of Eganville;
- b) Public Information Officer The Department has added a new position of Public Information Officer. The position will relay messages to the public and media regarding alerts, emergencies and disruptions in the Township in real time. Lorna Felske will hold this new position; and
- c) Equipment The department has 11 firefighting helmets that need to be replaced this year.
