

**THE CORPORATION OF

BY-LAW NO. 2023-049
BEING A BY-LAW TO ESTABLISH TARIFF OF FEES FOR THE
TOWNSHIP OF BONNECHERE VALLEY**

WHEREAS Councils of local municipalities are empowered by Section 391 of the Municipal Act, R.S.O. 2001 to establish by-laws. Without limiting sections 9, 10 and 11, those sections authorize a municipality to impose fees or charges on person,

- (a) For services or activities provided or done by or on behalf of it;
- (b) For costs payable by it for services or activities provided or done by or on behalf of any other municipality or nay local board; and
- (c) For the use of it property including property under its control. 2006, c.32, Sched. A, 163 (1).

AND WHEREAS the Council of the Municipal Corporation of the Township of Bonnechere Valley deems it expedient to enact a by-law to establish a tariff of fees.

1. The fees and charges set out on the attached Schedules are hereby imposed and ratified. Set out as follows:

2. All fees and charges set out in this by-law shall be payable prior to the provision of the service unless an agreement in writing is made to the contrary and approved by a municipal official.
3. In the event any fee or charge imposed herein remains unpaid after provision of the service or is otherwise in arrears, such fees or charges may be added to the Tax Roll for any real property in the municipality, the owner of which is responsible for paying the fee or charge and shall be collected in like manner as municipal taxes.
4. Council does hereby delegate to the Chief Administrative Officer of the Township of Bonnechere Valley, the authority to administer such fees and charges and approve such forms and procedures as may be required for the efficient administration of the fees and charges.
5. The fees set out in this By-Law shall be increased at the rate of inflation, based upon the Consumer Price Index for Ontario, when Council deems it appropriate.
6. That all Council resolution or similar expressions, whether formal or informal, inconsistent with this By-Law shall be deemed to be rescinded.
7. This By-Law shall come into force and effect on the date of passing and rescinds By-Law 2023-028.
