REPORTS

Recreation and Culture

Kevin McGrath, Manager of Recreation and Culture, was present and gave his report.

- a) Arena Canadian Blood Services, blood donor clinic, has cancelled their hall rental due to the chairlift size and capacity. Committee requested that staff look into accessibility grants to replace the chair lift;
- b) Bridge Flowers The bridge flower boxes have been taken to Temperate Gardens for planting. The Horticultural Society will begin planting flowers around town in June;
- c) Centennial Park The flower beds in Centennial Park have all been cleaned up, trimmed and edged;
- d) Play Structures The new play structures for Centennial Park and Opeongo Park are scheduled to arrive and be installed on Friday May 22;
- e) Opeongo Park The cost to repair the shade structure that is attached to the Sebastopol Heritage Society museum building is approximately \$1200. Committee recommends proceeding with repairing the structure;
- f) Farmers Market The Farmers Market plans to set up a stand at legion field starting June 22nd with curbside pick of items ordered/purchased online if Covid-19 restrictions are still in place;
- g) Ballfield Plywood has been installed at ballfield entrances to prevent people from using it as a dog park;
- h) Cormac Park Kevin McGrath is coordinating with Roads Department to have a few trees cut down in Cormac Park;
- i) Welcome to Eganville Hill The Horticultural Society would like to have two directional signs erected at the Welcome to Eganville Hill to highlight the walk way;

- j) Tourist Booth The Tourist Booth and the washrooms will remain closed to the public;
- k) Summer Student Grants The Township has received one summer student grant for a Swim Instructor. The swim program for 2020 is cancelled due to Covid-19. A letter from Mayor Murphy will be sent to Cheryl Gallants Office officially requesting permission to transfer the summer student grant to fund another summer student.
