Nikolina Likarević, CEO, Bonnechere Union Public Library Bonnechere Valley Operational Review

Brian Weckwerth & Dave Kruger, Eganville & Area Community Development Group Brian and Dave updated Committee on the proposed wheel-chair accessible fishing dock. The dock will be called "Loggers Landing" and will be located on private property. The Rotary Club is involved in the project and will assist with the funding.

REPORTS

Recreation and Culture

Kevin McGrath, Manager of Recreation and Culture, was present and gave his report.

- a) Arena Minor hockey continues with controlled scrimmages and up to fifty spectators. Eganville House League is in a bubble with Barry's Bay Minor Hockey. Competitive Hockey, local Valley Storm team is in a bubble with Arnprior, Renfrew and Cobden;
- b) JrB Team They have fifty spectators in the stands and fourteen upstairs in the Eagle's Nest during games;
- c) Public skating started on October 25th with nine in attendance, on November 15th fifty attended and for the remaining public skating times there have been approximately twenty in attendance;
- d) Emma Normoyle has completed the Basic Refrigeration Course;
- e) Legion Field Dog owners are still using Legion Field to walk their dogs despite the posted signs;
- f) Centennial Park Signs have been installed for the outdoor rink Covid-19 protocols unsupervised arena maximum 25 skaters, maintain physical distances of six feet. There have been four floods put on the outdoor rink and if the

- weather cooperates it should be open by this weekend;
- g) Tree Lighting The tree lighting on Friday November 27, 2020 at 6:30 pm was well attended. A picture of the lights on the bridge was posted on social media;
- h) Dog Park Committee discussed the proposed dog park. Committee recommends that Kevin McGrath reach out to the Dog Park Committee and see what their fundraising plans are for 2021. The project will proceed once the group has fundraised \$10,000;
- i) Operational Review Committee reviewed the recommendations of Kevin McGrath, Recreation Manager that were in the Operational Review in relation to the Recreation Department;
- j) Shop Local Campaign In an effort to support our local business this holiday season, Community Development Officer, Dana Jennings has been featuring some of businesses on the Township's facebook page. The response and the feedback to the profiling has been greatly received. To date the following have been profiled: My Country Home, Eganville Shell Station, Rio Tap and Grill, Eganville's Finest, O'Grady's Flowers and Gifts, Rusty Lantern Barn Boutique, The Granary Restaurant, Fifth Chute Coffee, Tiernary's Hair and Esthetics and Pumpkin's Posies, with more to come; and
- k) Safe Restart Phase II Funding Jennifer Murphy announced that Bonnechere Valley received \$200,000 for 2020 in Phase II funding, and an additional \$30,000 of funding for 2021 under the Safe Restart program.

a) 2021 Water & Sewer Budget – Committee recommends support of the 2021 Water & Sewer Budget as presented. The budget reflects a 1.5% increase to the 2021 water and sewer billings.

Annette Gilchrist, CAO, was present and gave her report.

- b) Comments were provided on the proposed regulation, and the proposed regulatory amendments, to make producers responsible for operating blue box programs;
- c) Comments were further provided, including resident's concerns, regarding the Algonquin proposed land settlement;
- d) Trailer By-Law CAO Annette Gilchrist prepared a draft by-law for Committee to review. The by-law was approved in principle; Staff direction was given to Annette Gilchrist, CAO to prepare notice for the public planning meeting and to seek clarification on a lawyer letter received which would be discussed publicly at the next Committee meeting;
- e) Property Standards A complaint was received regarding a property in the Village without windows. The property owner has indicated that they have the windows and will have them installed;
- f) Animal Control Staff have concluded their investigation regarding an ongoing dog complaint. After speaking with the Provincial Animal Welfare Inspector, OPP, Animal Control Officer and CBO the consensus is that there was an issue in the summer. The issue has been mostly resolved and the barking is now considered reasonable and only a minor annoyance according to the majority of the neighbours canvassed; and
- g) Health & Safety The Joint Health & Safety Committee met on December 7th to discuss the 2021 training requirements.

NEW/UNFINISHED BUSINESS

- Municipal Meeting with General Rick Hillier re Covid-149 Vaccine On Tuesday December 8th at 3:30pm Mayor Murphy along with all 441 Heads of Council in Ontario met with and General Rick Hillier and other officials to discuss the Covid-19 vaccination roll out. The vaccine will be rolled out in three phases. The first phase of the province's distribution plan will span two to three months and will focus on inoculating health care workers, residents, staff, essential caregivers, and other employees of congregate living settings that provide care for seniors, adults in Indigenous communities and adult recipients of chronic home health care. In April 2021, the province said it is expected that the second phase of the distribution plan will commence with a goal of ensuring every Ontarian who wants the vaccine can receive it. The third and final phase will essentially turn the administration of the COVID-19 vaccine into one similar to the system that distributes flu shots using pharmacies, physician's offices, and public health units;
- (2) Delcan Zoning By-Law Amendment Application to provide the correct zoning for a Marijuana Production Facility Committee did not discuss. Committee gave staff direction to return the incomplete application and request the application be completed and resubmitted;
- (3) Unconscious Bias, Inclusion and Diversity Committee gave staff direction to Annette Gilchrist, CAO to do some research on staff training programs, and policies and bring a report forward to Committee for further discussion;
- (4) Update on EACDG Jennifer Murphy updated the Committee on the Eganville and Area Community Development Group. Work on the accessible fishing dock continues. The group has a mural planned for the Tyerman and Daughters building, and they would like to paint the lines at McRae Park; and
