## **RE:** Emergency Declared for Renfrew County, Changes to Waste Site Hours during COVID-19 (Novel Coronavirus) and Council Meeting information for Residents

**Township of Bonnechere Valley** – **March 31, 2020** – At 2 pm on March 30, 2020, Renfrew County Warden Debbie Robinson declared an Emergency for the County of Renfrew due to the COVID-19 pandemic. The County of Renfrew is working collaboratively with the both the Provincial and Federal government as well as the local public health units to ensure the protection of all in Renfrew County. The County of Renfrew has activated its Emergency Response Plan and the Emergency Operations Centre is operational.

Bonnechere Valley Residents, please be advised that all the waste sites are open at this time during COVID-19. All residents may use any of the township's transfer waste sites to recycle your materials and dispose of your waste. Please recycle and compost as much as possible. Bulky waste as well as Construction and Demolition materials must be taken to the Sno Drifters site only. At this time is no charge at Sno Drifters to dispose of your materials. Effective, April 1, 2020, we are implementing Summer Hours at all of our sites. *Please note: This does not include the municipal household hazardous waste depot at Sand Road as it will remain closed until further notice.* Please see below the listing of hours.
