Recreation and Culture

- f) Arena Board and Olympia Ice Resurfacing Machine Sponsors The arena has been successful in addition two new sponsors to the arena boards and the Olympia ice surfacing machine;
- g) Christmas Party The date for the Bonnechere Valley Christmas Party is Saturday, December 7, 2019;
- h) Splash Pad Committee discussed and Kevin McGrath will shorten the timing on the splash pad from 4 mins to 1 min. The Splash Pad will be shutting down in two weeks at the latest.
