The Fire Chief emphasized that as always, education is at the fore front, but that tickets are for extraordinary circumstances at the discretion of the Fire Chief; and
- c) Drone Program The Ontario Fire College is currently offering drone pilot training. Several staff members have expressed interest and have filed applications. The department currently employs an advanced drone pilot and plans to embark on a drone program in 2020.
