WHEREAS: under the current legislative and regulatory framework there is no minimum setbacks between cannabis production facilities and sensitive odour receptors, including home and public facilities;

AND WHEREAS odour impacts on local communities and residents from cannabis production facilities include concerns from medical practioners about these impacts;

NOW THEREFORE BE IT RESOLVED THAT the Township of Bonnechere Valley calls for a review and amendments to the Cannabis Act and the current legislative framework for cannabis in Canada to help manage public impacts of cannabis production facilities;

AND FURTHER THAT production facilities, including facilities used by a designated person to produce cannabis for an individual's medical purposes, be required to confirm with the local municipality that the facility/site selected complies with all local municipal by-laws and regulations prior to an application being approved by Health Canada;

AND FURTHER THAT we request that Health Canada implement a system of minimum setbacks between cannabis production facilities and sensitive odour receptors, including home and public facilities;

AND FINALLY THAT a copy of this resolution be sent to the Federation of Canadian Municipalities (FCM), Ministry of Agriculture, Food and Rural Affairs (OMAFRA), Premier of Ontario, Provincial Minister of Municipal Affairs and Housing, Member of Parliament Provincial Member of Parliament, Federal Minister of Agriculture and Agri-Food and the Federal Minister of Health.
