9. DETACHMENT COMMANDER REPORT – Inspector Stephan Neufeld and S/Sgt Sarah Darraugh presented the Board with the following statistics from the Detachment: Criminal Code and Provincial Statute Charges Laid, Traffic Related Charges, e-Ticketing Warnings, Violent Crimes, Property Crimes, Drug Crime, Other Crime Occurrences, Public Complaints, Youth Charges, Mental Health Act Occurrences, and Overdose Occurrences.

b) Community Representatives - The Board directed the Secretary-Treasurer to advertise for the two Community Representatives in the Eganville Leader and the Valley Gazette. They will be reviewed by the Administration Team and brought forward to the February 9, 2026 meeting for the Board to make their two recommendations. Each of the six municipalities and the First Nation Council **must** pass a resolution to appoint the member to the Killaloe OPP Detachment Board before the Community Representatives can sit on the Board. The municipalities and the First Nation will also advertise on their websites.

c) 2026 Budget

The Board will share of costs for the Board equally between each of the six municipalities and the First Nation. Estimates costs for 2026: Insurance \$5150, advertising \$1200, two Provincial Representatives \$600, two Community Representatives \$900, other costs \$700 for a total of \$8550. \$1225 each. Bonnechere Valley will incur the initial costs then invoice the remaining municipalities and First Nation. Carried
