COUNCIL VACANCY

A vacancy was declared at the September 2nd Council meeting for one (1) Councillor and Council has determined to fill this vacancy by appointment of applications, in accordance with Section 263 (1)(a) of the Municipal Act, 2001 and the policy outlined by the Clerk.

The term of this position is for the duration of the 2022-2026 term of Council, ending November 14, 2026.

A candidate for municipal office must be a qualified municipal elector as set out in the Municipal Elections Act, 1996 and fulfill all of the following requirements:

- Eighteen (18) years of age of older; and
- A Canadian citizen; and
- A resident of the Township of Bonnechere Valley, or an owner or tenant of land in the municipality or the spouse of such an owner or tenant; and
- Not prohibited from voting under any other Act or disqualified from holding municipal office.

Should these applications be accepted by council the following process will commence.

Each of the Candidates will be afforded the opportunity to address Council for a period of not more than two (2) minutes. The order of speaking will be determined by Lot. The Clerk will place the names of all Candidates in a container and randomly draw the names.

Each member of Council will be permitted two (2) questions to each Candidate.

Upon hearing all the submissions of the Candidates, Council will proceed to vote as follows:

- i. Members of Council will vote by way of public vote as required by the Municipal Act, 2001.
- ii. Candidate names will be displayed in alphabetical order, in the Council Chambers by the Clerk.
- iii. Members of Council will vote for one Candidate only.
- iv. The Clerk will place the names of all Members of Council in a container and randomly draw their names to select the order of the vote.
- v. Members of Council will verbally cast their vote for one (1) Candidate.
- vi. The Clerk will tabulate the results.
- viii. Where the votes cast are equal (one for each of the Candidates) then out of the four Candidates remaining the Clerk will by Lot select one such Candidate to be excluded from the subsequent voting; The Clerk will again tabulate the results.
- ix. If two (2) Candidates remain (each getting 2 votes of Council), the tie will be broken by selecting a Candidate by Lot, as conducted by the Clerk.

Upon conclusion of voting the appointment of the Candidate will be made by by-law.

The Clerk will administer the Declaration of Office required by subsection 232(1) of the Municipal Act, 2001.

I have lived in the Bonnechere Valley since 2012, and during that time have been involved in, and grown to love all things Eganville. I have held leadership roles in several community organizations, the experience from which, I believe can serve me well in the role as councillor.

I have been a board member at the Bonnechere Union Public Library (BUPL) since 2020 and developed marketing to increase library membership, drawing on an influx of new arrivals from both a mini housing boom and new apartment buildings. I redrafted an information brochure for BUPL, am involved in all fundraising activities, and attend and participate in monthly board meetings. Council needs to plan and react in a timely manner to growth and change in our valley.

As former President, and then Marketing and Advertising Director, my work with the Eganville and Area Horticultural Society (EAHS) taught me the importance of knowing and valuing participants, making dollars stretch to deliver value for money, and the importance of expressing gratitude to donors. I plant Eganville's summer flower boxes, and decorate them for winter too. I recognize keeping our village beautiful boosts business and tourism, and creates a valuable sense of pride-in-place. I want to contribute to the success of the Bonnechere Valley by participating on council and ensuring rate payers get the best value for their taxes.

As an Intergenerational Support Worker with the Echo Center (The Eganville and Area District Seniors Needs Association), I am keenly aware of the needs of our aging demographic. In this capacity I have a current Vulnerable Sector Check, and take advantage of every learning opportunity offered to me. I am bilingual (my BA from the University of Toronto is in French and German Literature and Linguistics), and I hold Able Toast Master Bronze status in public speaking.

I believe the role of councillor for the Bonnechere Valley requires dedication to learning policies, needs and requirements, listening and asking questions to support understanding, cooperation with fellow councillors to learn and share, punctuality and respect, and above all a heart for service to our community. I would be grateful to have the opportunity to fill the role of interim councillor, and am available for an interview at your convenience.

Hello! I have decided to put my name forward for the vacated position available on council for the remainder of the current term.

There are several reasons why I have decided to offer myself at this time. 1) I received encouragement and requests from residents, 2) I have the time, recently completing my contract with the federal government, 3) I have the experience having served on council from 2014-2018, 4) I served on the library board, so could easily get up to speed if needed in that capacity and 4) I have the interest to serve my community for a short period of time, however I do not have the intention to seek a council position in the next election, so my serving would not give an advantage.

I will share a little about my experience and achievements to give a fuller picture. Before I moved to Bonnechere Valley in 2009, I lived in Toronto where I was a film and television producer, winning several awards and nominations for my work. I am both a creative and business minded person. My volunteer work was in the political realm.

When I was on council, in one term I was able to accomplish some significant achievements including spearheading the creation of the newsletter, a new approach to partnership with the provincial government and rural municipalities, advocating for funding that saw our local arena receive a large investment. This took the burden of a major renovation from hampering our tax base. Another initiative that I spearheaded was the introduction of a referendum on changing the election of councillors from a ward system to at large, so that residents can vote for a full make up of their representatives. In my last election, based on uneven ward distribution, I received the second most votes by electorates but ultimately lost by 40ish votes..

I thoroughly enjoyed contributing to our community through council, whether it was steering through some rocky waters at the library, collaborating on 125 events for Eganville's 125th anniversary and a time capsule, to making decisions to keep the tax rate affordable, with an eye to quality of life issues and community building.

Since leaving council I have had some truly incredible experiences that have only deepened what I can offer our residents. I was the Senior Advisor to two cabinet ministers. First I was the Ontario Advisor to the Minister of Intergovernmental Affairs and Infrastructure. I coordinated efforts between the Federal Govt and Govt of Ontario during the pandemic and beyond. I was headhunted for a position at the RCDSB, by the former Director of Education, but returned to Government to spearhead a National Summit on Combating Antisemitism.

The qualities that I believe make me most suited include an open and collaborative style, transparency, good judgment, excellent communications, deep political knowledge on how to get things done and full understanding of municipal rules.





When William MacDonald came back to the local area five years ago, it was the sense of community
that pulled him back.

Now, the resident of geared-to-income housing at 11 Hastings Drive is infusing some Christmas spiri into that community by organizing a Christmas dinner for residents of the complex on Sunday.
And the community has come forward to help, with local businesses donating to the effort to ensure a group of less fortunate area residents gets a taste of the giving season.

"It's looking like it's going to be a beautiful dinner," said MacDonald.

A mechanic by trade who is now on disability for health reasons, MacDonald grew up in the Sparkle City area just north of Prescott.

He came back here after spending some time in Vancouver.

The sad reality is many residents of geared-to-income housing have nowhere to go and nobody to see on a day most people associate with family get-togethers.

The complex on Hastings Drive is home to 48 people, but others may also join them.

"We've reached out to some of the neighbours who are also in housing and have nowhere to go," said MacDonald.

The dinner will take place on Sunday from 4 p.m. to 6 p.m.

Butcher Shop owner Rick Orr said his business, which often donates to community causes, will provide ham for the Hastings dinner.

"I thought it was kind of neat," he said.

Moira Taylor, owner of Food for Thought Catering, said MacDonald's work fits nicely with her ministry.

"Bill has done some wonderful things," said Taylor, an ordained minister who also runs People Investing In People Ministries.

Butcher Shop owner Rick Orr said his business, which often donates to community causes, will provide ham for the Hastings dinner.

"He's been an instigator in bringing people in his building together."

Taylor added poverty is all too prevalent in Brockville and she wanted to support MacDonald in his efforts to bring Christmas to some less fortunate residents.

"It can show other people what they can do, too," she added.

THEREFORE, the Council of the Corporation of the Township of Bonnechere Valley enacts as follows:

- 1. THAT the action of the Council of the Corporation of the Township of Bonnechere Valley in respect to each recommendation contained in the reports of the Committees and in respect to each motion, resolution and other action passed and taken by the Council at its said regular meeting, is hereby adopted, ratified and confirmed as if all such proceedings were expressly embodied in this by-law.
- 2. The Mayor or in her absence, the Presiding Officer of the Council and the proper officials of the Municipality are hereby authorized and directed to do all things necessary to give effect to the said action or to obtain approvals where required.
- 3. The Mayor or in his/her absence the Presiding Officer and the Clerk or in his/her absence the other designated signing officer, are hereby directed to execute all documents required by Statute to be executed by them, as may be necessary in that behalf and to affix the Corporate Seal of the Municipality to all such documents.
- 4. THAT in the event any provision or provisions of this by-law be deemed illegal or not enforceable, it or they shall be considered separate and severable from the by-law, and its remaining provisions shall remain in force and be binding as though the said provision or provisions had never been included.
